# **EXECUTIVE SYNOPSIS**

#### **DOSSIER NOTES**

In preparing this background report, we undertook an examination of all readily available and relevant electronic and online records, several hundred Nexis and news articles, dozens of active and archived web pages, and several dozen public records from Nexis and the resources of various federal, state, and municipal government offices. The results of our analysis are contained below.

*Typographical Note:* There are a number of articles quoted in this report that contain typographical errors. These are from the original text of the article and have not been corrected when being quoted directly.

#### MAIN VULNERABILITIES

# Personal And Professional Foibles

In both his personal and professional life, Jason Minnicozzi boasts several vulnerabilities which others may seek to capitalize on.

Most notably, Minnicozzi may be accused of not fairly prosecuting allegations of child pornography against a powerful local politician's son. In June 2018, Justin Brochure, the son of Oak Island Mayor Cynthia Brochure, was charged with 31 counts of second degree child exploitation of a minor. Brochure was originally held on a \$1 million bond, but was later reduced to \$100,000 as part of an agreement. Brochure agreed to no contact with minors; however, a month later, Brochure was charged with 11 counts of violation his pretrial release agreement and held under a \$2 million bond; however, this was reduced to only \$50,000. In May 2019, Brochure was released from custody after pleading "no contest" in a plea agreement "stemming from 62 counts of sexual exploitation of a minor charges — 31 in the second degree and 31 in the third. Minnicozzi, who was the lead prosecutor in the case, agreed to no prison time for Brochure as part of the plea agreement and his no contest plea allowed Brochure to not admit to any crime. The plea agreement procured by Minnicozzi was described as a "stark contrast" with other child pornography cases that Minnicozzi given that the same week as Brochure's agreement, Minnicozzi prosecuted a 27-year-old who was sentenced to at least 10 years in prison "despite facing fewer charges than Brochure." The Mother of the boy who was known to have been in Brochure's company while he was out on bail said "the system is broken" and expressed concerns about how Brochure's mother's role as mayor may have impacted the investigation."

Furthermore, Minnicozzi has a track record of interactions with law enforcement. A little over a decade ago, in January 2010, Minnicozzi was charged with driving while impaired on suspicion of driving while intoxicated, during which he refused blood alcohol level tests at the time of his arrest. In December 2011, Minnicozzi pleaded guilty to driving while intoxicated. Similarly, in February 2003, Minnicozzi was charged with possession of marijuana, possession of drug paraphernalia, and unsafe movement. In March 2004, all of the charges were dismissed. Additionally, in October 2002, Minnicozzi was charged with disturbing the peace; this charge

was dismissed by the district attorney. In January 2002, Minnicozzi was charged with underage possession of a malt beverage; this charge was dismissed following a deferred prosecution agreement.

As a public defender, Minnicozzi sought to assist several child predators. In 2014, Minnicozzi, as a public defender, made a motion to suppress evidence in a case against his client who was accused of sexual exploitation of a minor; Minnicozzi contended that his client's cell phone was unlawfully searched. In 2015, Minnicozzi, as a public defender, contended his client, who plead guilty to first-degree sexual offense of a child, among other charges, was unfairly charged as an adult since the crimes took place when his client was only 17.

# Embrace Of Liberal Policies And Leftist Politics

Despite claiming he is not a "cookie-cutter Democrat," a review of Minnicozzi's public comments and social media accounts has revealed blatant support for the left's policy agenda and politics.

Through social media, Minnicozzi has indicated he supports several fiscally responsible policies. Minnicozzi has indicated he supports some form of tax increase on wealthier Americans. Minnicozzi also has indicated increasing wage mandates on North Carolina businesses. Notably, Minnicozzi has indicated the U.S. should reduce military spending.

On healthcare, Minnicozzi has adopted most aspects of the progressive healthcare agenda – including Medicaid expansion, Obamacare, and universal healthcare. During the covid-19 pandemic, Minnicozzi frequently used social media to express support for mask mandates. For example, in March 2021, Minnicozzi tweeted that it was "too soon to relax or eliminate mask mandates and other mitigation efforts."

Perhaps most alarming is Minnicozzi's apparent agreement with radical "squad" members on several issues (anti-police and immigration). In April 2021, Minnicozzi promoted a post by Rep. Omar That called to "disband and deconstruct failed police departments". In January 2021, Minnicozzi promoted post by AOC claiming that pro-police slogans by Republicans were to "uphold a system of state violence that targets black people and people of color". Separately, Minnicozzi has promoted calls from AOC to "abolish" immigration and customs enforcement.

On social issues, Minnicozzi is in lockstep with the left. Minnicozzi is pro-abortion and appears to support Planned Parenthood. Additionally, Minnicozzi has expressed anti-second amendment sentiments and is opposed to the death penalty. Minnicozzi appears to have embraced leftist racial politics including support for Colin Kaepernick's national anthem protests.

Minnicozzi is endorsed by several "progressive" organizations that support rigid left-leaning agendas. The Carolina Forward Slate, a group focused on "bold, progressive leadership," supports "affordable housing, universal healthcare, racial justice, environmental protection…" According to Carolina Forward's website, the Carolina Forward Slate supported Gov. Cooper's vetoing of commonsense legislation that sought to unwind Covid-related heavy-handedness and seek a return to normalcy. Additionally, Minnicozzi is endorsed by Work For Democracy, "a

progressive grassroots movement". Work For Democracy promotes "universal access to healthcare" and "reproductive freedom for women."

Additionally, Minnicozzi has taken up radical political positions. Notably, Minnicozzi supports efforts to consolidate liberal power in Washington through ending the filibuster and granting D.C. statehood. Minnicozzi has expressed a backing for Stacey Abrams and has indicated he supports varying forms of censorship on social media.

Notably, in January 2021, Minnicozzi promoted a tweet that appeared to attempt dark humor through suggestion that Josh Hawley was beneath comparison to Hitler.

NOTE: Jason Minnicozzi has never run for elected public office. Minnicozzi initial ran for the U.S. House of Representatives for North Carolina's seventh district, but dropped out for his current campaign for the North Carolina State Senate.

#### **CAMPAIGN FINANCE**

Jason Minnicozzi has not yet reported any campaign finance documents since declared his candidacy for the North Carolina State Senate. Prior to dropping out to run for the North Carolina State Senate for District Seven, Minnicozzi received an aggregate of \$133,928.31 for his campaign for the U.S. House of Representatives for North Carolina's seventh district. # MINNICOZZI'S PERSONAL AND PROFESSIONAL FOIBLES

In both his personal and professional life, Jason Minnicozzi boasts several vulnerabilities which others may seek to capitalize on.

Most notably, Minnicozzi may be accused of not fairly prosecuting allegations of child pornography against a powerful local politician's son. In June 2018, Justin Brochure, the son of Oak Island Mayor Cynthia Brochure, was charged with 31 counts of second degree child exploitation of a minor. Brochure was originally held on a \$1 million bond, but was later reduced to \$100,000 as part of an agreement. Brochure agreed to no contact with minors; however, a month later, Brochure was charged with 11 counts of violation his pretrial release agreement and held under a \$2 million bond; however, this was reduced to only \$50,000. In May 2019, Brochure was released from custody after pleading "no contest" in a plea agreement "stemming from 62 counts of sexual exploitation of a minor charges — 31 in the second degree and 31 in the third. Minnicozzi, who was the lead prosecutor in the case, agreed to no prison time for Brochure as part of the plea agreement and his no contest plea allowed Brochure to not admit to any crime. The plea agreement procured by Minnicozzi was described as a "stark contrast" with other child pornography cases that Minnicozzi given that the same week as Brochure's agreement, Minnicozzi prosecuted a 27-year-old who was sentenced to at least 10 years in prison "despite facing fewer charges than Brochure." The Mother of the boy who was known to have been in Brochure's company while he was out on bail said "the system is broken" and expressed concerns about how Brochure's mother's role as mayor may have impacted the investigation."

Furthermore, Minnicozzi has a track record of interactions with law enforcement. A little over a decade ago, in January 2010, Minnicozzi was charged with driving while impaired on suspicion of driving while intoxicated, during which he refused blood alcohol level tests at the time of his arrest. In December 2011, Minnicozzi pleaded guilty to driving while intoxicated. Similarly, in February 2003, Minnicozzi was charged with possession of marijuana, possession of drug paraphernalia, and unsafe movement. In March 2004, all of the charges were dismissed. Additionally, in October 2002, Minnicozzi was charged with disturbing the peace; this charge was dismissed by the district attorney. In January 2002, Minnicozzi was charged with underage possession of a malt beverage; this charge was dismissed following a deferred prosecution agreement.

As a public defender, Minnicozzi sought to assist several child predators. In 2014, Minnicozzi, as a public defender, made a motion to suppress evidence in a case against his client who was accused of sexual exploitation of a minor; Minnicozzi contended that his client's cell phone was unlawfully searched. In 2015, Minnicozzi, as a public defender, contended his client, who plead guilty to first-degree sexual offense of a child, among other charges, was unfairly charged as an adult since the crimes took place when his client was only 17.

Among items found were videos of a man engaging in sex with a dog and photos depicting young girls being molested, court documents reveal. After contacting T-Mobile to identify the owner, police secured a search warrant for the Chestnut Street home of 33-yearold Derek Scott Price. Price was arrested on 18 counts of sexual exploitation of a minor and one count of crimes against nature. While Price remains in jail in lieu of \$350,000 bail and is awaiting his day in court, a recent U.S. Supreme Court opinion puts the government's case -- and an unknown number of other cases that have cellphone searches at their core -- in jeopardy. "But for the unlawful search, the officers would not have had probable cause to search Price's home nor would officers had a probable cause to arrest Price," Price's court-appointed public defender Jason Minnicozzi wrote in a July 14 motion to suppress the evidence. "Thus, under the fruit of the poisonous tree doctrine, all evidence against Price is the tainted fruit of an unlawful search." Minnicozzi's motion is based on the June 25 opinion by the U.S. Supreme Court that declared cellphones constitutionally protected items searchable only by warrants." (F.T. # MINNICOZZI'S EMBRACE OF LIBERAL POLICIES AND LEFTIST POLITICS

Despite claiming he is not a "cookie-cutter Democrat," a review of Minnicozzi's public comments and social media accounts has revealed blatant support for the left's policy agenda and politics.

Through social media, Minnicozzi has indicated he supports several fiscally responsible policies. Minnicozzi has indicated he supports some form of tax increase on wealthier Americans. Minnicozzi also has indicated increasing wage mandates on North Carolina businesses. Notably, Minnicozzi has indicated the U.S. should reduce military spending.

On healthcare, Minnicozzi has adopted most aspects of the progressive healthcare agenda—including Medicaid expansion, Obamacare, and universal healthcare. During the covid-19 pandemic, Minnicozzi frequently used social media to express support for mask mandates. For example, in March 2021, Minnicozzi tweeted that it was "too soon to relax or eliminate mask mandates and other mitigation efforts."

Perhaps most alarming is Minnicozzi's apparent agreement with radical "squad" members on several issues (anti-police and immigration). In April 2021, Minnicozzi promoted a post by Rep. Omar That called to "disband and deconstruct failed police departments". In January 2021, Minnicozzi promoted post by AOC claiming that pro-police slogans by Republicans were to "uphold a system of state violence that targets black people and people of color". Separately, Minnicozzi has promoted calls from AOC to "abolish" immigration and customs enforcement.

On social issues, Minnicozzi is in lockstep with the left. Minnicozzi is pro-abortion and appears to support Planned Parenthood. Additionally, Minnicozzi has expressed anti-second amendment sentiments and is opposed to the death penalty. Minnicozzi appears to have embraced leftist racial politics including support for Colin Kaepernick's national anthem protests.

Minnicozzi is endorsed by several "progressive" organizations that support rigid left-leaning agendas. The Carolina Forward Slate, a group focused on "bold, progressive leadership," supports "affordable housing, universal healthcare, racial justice, environmental protection..." According to Carolina Forward's website, the Carolina Forward Slate supported Gov. Cooper's vetoing of commonsense legislation that sought to unwind Covid-related heavy-handedness and seek a return to normalcy. Additionally, Minnicozzi is endorsed by Work For Democracy, "a progressive grassroots movement". Work For Democracy promotes "universal access to healthcare" and "reproductive freedom for women."

Additionally, Minnicozzi has taken up radical political positions. Notably, Minnicozzi supports efforts to consolidate liberal power in Washington through ending the filibuster and granting D.C. statehood. Minnicozzi has expressed a backing for Stacey Abrams and has indicated he supports varying forms of censorship on social media.

Notably, in January 2021, Minnicozzi promoted a tweet that appeared to attempt dark humor through suggestion that Josh Hawley was beneath comparison to Hitler.

### **Sexual Exploitation Of Minor Case - 2014**

In 2014, Minnicozzi, As A Public Defender, Made A Motion To Suppress Evidence In A Case Against His Client Who Was Accused Of Sexual Exploitation Of A Minor; Minnicozzi Contended That His Client's Cell Phone Was Unlawfully Searched. "An anonymous package delivered to the New Hanover County Sheriff's Office in December contained a cellphone and a note. "Found this phone with very disturbing pictures on it including child pornography," the unsigned paper wrapped around the phone read. Two sheriff's office investigators viewed the phone's contents. Among items found were videos of a man engaging in sex with a dog and photos depicting young girls being molested, court documents reveal. After contacting T-Mobile to identify the owner, police secured a search warrant for the Chestnut Street home of 33-yearold Derek Scott Price. Price was arrested on 18 counts of sexual exploitation of a minor and one count of crimes against nature. While Price remains in jail in lieu of \$350,000 bail and is awaiting his day in court, a recent U.S. Supreme Court opinion puts the government's case -- and an unknown number of other cases that have cellphone searches at their core -- in jeopardy. "But for the unlawful search, the officers would not have had probable cause to search Price's home nor would officers had a probable cause to arrest Price," Price's court-appointed public defender Jason Minnicozzi wrote in a July 14 motion to suppress the evidence. "Thus, under the fruit of the poisonous tree doctrine, all evidence against Price is the tainted fruit of an unlawful search." Minnicozzi's motion is based on the June 25 opinion by the U.S. Supreme Court that declared cellphones constitutionally protected items searchable only by warrants." (F.T. ### Sexual Offense Of A Child – 2015

In 2015, Minnicozzi, As A Public Defender, Contended His Client, Who Plead Guilty To First-Degree Sexual Offense Of A Child, Among Other Charges, Was Unfairly Charged As An Adult Since The Crimes Took Place When His Client Was Only 17. "A Wilmington teen was sentenced to at least 18 years in prison Tuesday for the molestation of two boys at a Boy Scout camp in Carolina Beach last summer. Timothy Grant Shaw II, 18, pleaded guilty to nine counts of first-degree sexual offense of a child, one count of second-degree sexual exploitation of a minor, one count of third-degree sexual exploitation of a minor and one count of dissemination of obscenity... "It's a shame that in North Carolina that this young man is before this court as an adult, because he is not. He was 17 when this happened... These actions are the actions of a child," said Shaw's attorney, public defender Jason Minnicozzi. He said Shaw also was a victim of molestation at the hands of a neighbor when he was 5. Minnicozzi read to the court a letter Shaw wrote the victims upon his arrest. In it Shaw apologized for his actions. "I only did what I did because I was sad and lonely," Shaw wrote." (F.T.
