EXECUTIVE SYNOPSIS

DOSSIER NOTES

In preparing this background report, we undertook an examination of all readily available and relevant electronic and online records, several hundred Nexis and news articles, dozens of active and archived web pages, and several dozen public records from Nexis and the resources of various federal, state, and municipal government offices. The results of our analysis are contained below.

Typographical Note: There are a number of articles quoted in this report that contain typographical errors. These are from the original text of the article and have not been corrected when being quoted directly.

MAIN VULNERABILITIES

Morgan's Fiscally Irresponsible, Big-Government Platform

A review of Morgan's public actions has revealed a record of supporting a fiscally irresponsible, big-government platform.

On fiscal issues, Morgan appears supportive of the traditional tax-and-spend liberal approach. Specifically, Morgan has criticized tax cuts for corporations and higher earners. In 2018, Morgan opposed a constitutional amendment that sought to reduce the maximum allowable income tax rate in North Carolina. In 2020, Morgan used social media to implicitly provide support for a wealth tax and criticize the accrual of wealth. Morgan has also expressed support for wage mandates on North Carolina businesses. Unsurprisingly, Morgan has earned the support of prominent labor unions.

On energy issues, Morgan supports the left's anti-growth agenda. Morgan is vehemently opposed to offshore drilling in North Carolina and has called for the imposition of significantly stricter environmental regulations. More specifically, Morgan has called for "getting rid of the Hardison Amendment which prevents [North Carolina] from adopting stricter standards than the federal government." On social media, Morgan has been critical of fossil fuels and has indicated support for a "carbon neutral by 2040" policy. Unsurprisingly, Morgan has earned the support of environmentalist groups.

On education, Morgan opposes school choice efforts. Morgan has noted she supports "phasing out school vouchers for private schools" and a "moratorium on new charter schools" until stronger regulations have been imposed. Additionally, Morgan opposes public funds being sent to private schools and calls for oversight of charter school programs before receiving taxpayer funding.

On healthcare, Morgan appears in lock step with Democrats. Morgan has been a vocal supporter of Medicaid expansion. Moreover, Morgan supported the left's big-government reaction to covid. Specifically, Morgan called for mask wearing and social distancing and criticized calls to loosen covid restrictions.

Morgan Supports The Left's Woke Social And Public Safety Agenda

Morgan appears eager to promote the left's reckless 'woke' social agenda at the expense of public safety.

Morgan is predictably far-left leaning on issues surrounding immigration. Morgan appears opposed to ICE. On social media, Morgan indicated support for content from AOC praising Sen. Ed Markey after he announced his support for abolishing ICE and establishing "a pathway to citizenship for all 11 million undocumented immigrants in our country". Additionally, Morgan has been steadfast in her opposition to legislation that would have required North Carolina sheriffs to comply with ICE detainers. Moreover, Morgan has personally indicated support for the Obama-era amnesty program known as DACA. Morgan has also criticized border enforcement measures -- specifically the Trump Administration's southern border wall.

Morgan has also embraced a series of radical law enforcement and criminal justice reforms. Most concerning, in 2020, Morgan joined other Democrats in signing a pledge "to defund the police, restrict the ability of law enforcement to obtain basic protective equipment and strip citizens of second amendment rights with no due process". Separately, in 2020, Morgan encouraged participation in an initiative pushing several anti-law and order positions. The Morgan-backed initiative "called for ending cash bail and predatory fines and fees; an end to military training for law enforcement; investing federal funds into efforts to desegregate schools; and moving immigration oversight out of the Department of Homeland Security." On social media, Morgan has promoted content critical of the police and has noted that she wished she could have joined Black Lives Matter in protests during the summer of 2020. Notably, Morgan has opposed a Victim's Rights Amendment.

On traditional social issues, Morgan is in lockstep with the left's agenda. Morgan appears to be unapologetically pro-abortion. Specifically, Morgan protested the Supreme Court's decision to overturn Roe V. Wade and is a supporter of Planned Parenthood and other pro-abortion groups. Morgan is noted to have pushed progressive LGBTQ positions. Morgan supports the passage of an Equal Rights Amendment and was an outspoken critic of North Carolina's controversial transgender bathroom bill. Additionally, Morgan has expressed anti-second Amendment sentiments. Morgan supports several strict gun control policies, including an assault weapons ban, universal background checks, and red flag laws. Notably, in 2018, Morgan opposed an amendment that protected the right of the people to hunt, fish, and harvest wildlife.

Finally, Morgan has pushed woke ideology as it relates to race. Morgan supports the concept of systemic racism, supports removal of confederate monuments, and has defended national anthem protests.

Morgan's Progressive Partisan Ties

Since entering the public domain Morgan has acted in a partisan manner, eager to embrace progressive individuals, policy platforms, and organizations.

Morgan appears to support the Democrat establishment's efforts to consolidate electoral power. Specifically, Morgan is opposed to common-sense voter ID laws.

Unsurprisingly, Morgan has indicated support for national liberal figures such as Roy Cooper, Bernie Sanders, Elizabeth Warren, Nancy Pelosi, and Barack Obama. Notably, Morgan indicated support for progressive activist Rev. William Barber.

On policy, Morgan has promoted the Poor People's Campaign, which pushes for major progressive policies. The Poor People's Campaign supports a single-payer Medicare for all system and Medicaid expansion, calls for higher taxes on the wealthy and corporations, demands "100 percent clean, renewable energy and a public jobs program to transition to a green economy that will put millions of people in sustainable living wage jobs", and calls for an end to "military aggression" and seeks to defund the military.

Notably, Morgan has enjoyed the support of dark-money liberal and progressive groups.



MORGAN'S FISCALLY IRRESPONSIBLE, BIG-GOVERNMENT PLATFORM

A review of Morgan's public actions has revealed a record of supporting a fiscally irresponsible, big-government platform.

On fiscal issues, Morgan appears supportive of the traditional tax-and-spend liberal approach. Specifically, Morgan has criticized tax cuts for corporations and higher earners. In 2018, Morgan opposed a constitutional amendment that sought to reduce the maximum allowable income tax rate in North Carolina. In 2020, Morgan used social media to implicitly provide support for a wealth tax and criticize the accrual of wealth. Morgan has also expressed support for wage mandates on North Carolina businesses. Unsurprisingly, Morgan has earned the support of prominent labor unions.

On energy issues, Morgan supports the left's anti-growth agenda. Morgan is vehemently opposed to offshore drilling in North Carolina and has called for the imposition of significantly stricter environmental regulations. More specifically, Morgan has called for "getting rid of the Hardison Amendment which prevents [North Carolina] from adopting stricter standards than the federal government." On education, Morgan opposes school choice efforts. Additionally, Morgan opposes public funds being sent to private schools and calls for oversight of charter school programs before receiving taxpayer funding.

On healthcare, Morgan appears in lock step with Democrats. Morgan has been a vocal supporter of Medicaid expansion. Moreover, Morgan supported the left's big-government reaction to covid. Specifically, Morgan called for mask wearing and social distancing and criticized calls to loosen covid restrictions.





MORGAN SUPPORTS THE LEFT'S WOKE SOCIAL AND PUBLIC SAFETY AGENDA

Morgan appears eager to promote the left's reckless 'woke' social agenda at the expense of public safety.

Morgan is predictably far-left leaning on issues surrounding immigration. Morgan appears opposed to ICE. On social media, Morgan indicated support for content from AOC praising Sen. Ed Markey after he announced his support for abolishing ICE and establishing "a pathway to citizenship for all 11 million undocumented immigrants in our country". Additionally, Morgan has been steadfast in her opposition to legislation that would have required North Carolina sheriffs to comply with ICE detainers. Moreover, Morgan has personally indicated support for the Obama-era amnesty program known as DACA. Morgan has also criticized border enforcement measures -- specifically the Trump Administration's southern border wall.

Morgan has also embraced a series of radical law enforcement and criminal justice reforms. Most concerning, in 2020, Morgan joined other Democrats in signing a pledge "to defund the police, restrict the ability of law enforcement to obtain basic protective equipment and strip citizens of second amendment rights with no due process". Separately, in 2020, Morgan encouraged participation in an initiative pushing several anti-law and order positions. The Morgan-backed initiative "called for ending cash bail and predatory fines and fees; an end to military training for law enforcement; investing federal funds into efforts to desegregate schools; and moving immigration oversight out of the Department of Homeland Security." On social media, Morgan has promoted content critical of the police and has noted that she wished she could have joined Black Lives Matter in protests during the summer of 2020. Notably, Morgan has opposed a Victim's Rights Amendment.

On traditional social issues, Morgan is in lockstep with the left's agenda. Morgan appears to be unapologetically pro-abortion. Specifically, Morgan protested the Supreme Court's decision to overturn Roe V. Wade and is a supporter of Planned Parenthood and other pro-abortion groups. Morgan is noted to have pushed progressive LGBTQ positions. Morgan supports the passage of an Equal Rights Amendment and was an outspoken critic of North Carolina's controversial transgender bathroom bill. Additionally, Morgan has expressed anti-second Amendment sentiments. Morgan supports several strict gun control policies, including an assault weapons ban, universal background checks, and red flag laws. Why it is problematic: Morey sees this amendment as "baiting voters." It is very likely the average person will see this amendment as inconsequential. Yet the amendment still poses a threat. Any restriction to hunting and fishing, however reasonable, could be in danger if the amendment is passed. For example, there are currently statutes in effect that limit hunting in certain public areas. The passage of this amendment could result in the loosening of these restrictions as hunting rights enshrined in the constitution take priority.

Since entering the public domain Morgan has acted in a partisan manner, eager to embrace progressive individuals, policy platforms, and organizations.

314 Action Is Regarded As A "Dark Money" Organization Due To Its Undisclosed • Donations To Its Non-Profit Arm. "Linda Kenney, a professor of microbiology at the University of Illinois at Chicago College of Medicine, says something has to be done about the "dumbing down of science" by politicians. After reading about a group called 314 Action working to elect scientists to public office, it did not take much for Kenney to open her wallet. Now Kenney says she donates about \$100 monthly to the group. "This is way overdue," she says. "I don't know if it's money well spent, but it's something I can do and I believe in it." Kenney agreed to discuss her contirbutions for this story. But 314 Action plans to raise \$5 million to \$7 million for current candidates, and it will be impossible to know where the bulk of the money is coming from. That is because the group, named for the first three digits of pi, is taking advantage of a widely used and controversial campaign finance apparatus: a nonprofit arm that does not disclose its donors. This practice has been dubbed the use of "dark money" in the political world. It has become fairly standard for groups of all stripes-from Republicans to Democrats and from powerful business interests to unions. Planned Parenthood uses these undisclosed donations. So does the National Rifle Association. It is legal. But the practice also means the general public cannot learn much about the original sources of money behind political candidates. Aside from its nonprofit, 314 Action is also raising and spending money via a separate political action committee, or PAC, that is required to report donors to the Federal Election Commission (FEC). But most of the group's funds will come from the nonprofit arm, which has no such requirement. It is registered as a "social welfare" group under section 501(c)(4) of the U.S. tax code. Nonprofits such as this, which advocate for policy issues, are forbidden from contributing directly to candidates. Nor are they allowed to make electioneering their primary activity. But they are allowed to spend some of their money on political TV ads, radio spots, mailers and digital communication to support or oppose candidates without having to disclose donors." "Forty-Seven Democratic members of the state House and candidates running to join the Democratic caucus have signed a pledge to defund the police, restrict the ability of law enforcement to obtain basic protective equipment and strip citizens of Second Amendment rights with no due process. The pledge includes ending cash bail and the assignment of court fees and costs, one which would return some dangerous criminals back to the streets, the other which would further defund the police by eliminating revenue for police training and police retirement. Eight Democratic state Senate members and candidates also signed the pledge. While not all current Democrat house members signed the pledge, if all 47 of the pledge signers were elected, they would represent 85% of the current 55 Democrat members of the state House. Included in part of the pledge is the policy statement: "Police funding...has been shown to have no connection to crime rates" House Speaker Tim Moore (R-Kings Mountain) scheduled a press conference for Monday, Sept. 14 and released the following statement: "This radical pledge by House Democrats to defund police in North Carolina is a betrayal of the basic public trust to keep families safe, particularly in times of crisis, as crime rates rise in other areas led by the radical left," Moore said. "Assessing expenditures on policing to identify evidence-based ways to generate savings...especially communities most impacted by current policing practices," is an official policy promise of House Democratic leaders and candidates to North Carolinians," Moore continued. "It is stunning that House Democrats in North Carolina would sign a pledge to defund law enforcement, and that so many in their caucus would join with radical national liberals promising to cut funding for police officers who protect innocent people." Moore further noted that in exchange for at least \$100,000 in donations, House Democratic candidates pledged to enact legislation requiring "a comprehensive review of the state's police funding" to "reduce excessive policing." 



Hunting and Fishing Amendment

What it is: "Constitutional amendment protecting the right of the people to hunt, fish, and harvest wildlife."

Why it is problematic: Morey sees this amendment as "baiting voters." It is very likely the average person will see this amendment as inconsequential. Yet the amendment still poses a threat. Any restriction to hunting and fishing, however reasonable, could be in danger if the amendment is passed. For example, there are currently statutes in effect that limit hunting in certain public areas. The passage of this amendment could result in the loosening of these restrictions as hunting rights enshrined in the constitution take priority.

"It is not the only thing I'm running on, but it is one of the things," said Democrat Marcia Morgan, who's running for a House seat in New Hanover County. A former Army officer and a lesbian, Morgan said HB2 symbolizes "the regressive policies of the current legislature." Two Democrats running in Bishop's District 39 are also talking about HB2." 



• **314** Action Is Regarded As A "Dark Money" Organization Due To Its Undisclosed Donations To Its Non-Profit Arm. "Linda Kenney, a professor of microbiology at the University of Illinois at Chicago College of Medicine, says something has to be done about the "dumbing down of science" by politicians. After reading about a group called 314 Action working to elect scientists to public office, it did not take much for Kenney to open her wallet. Now Kenney says she donates about \$100 monthly to the group. "This is way overdue," she says. "I don't know if it's money well spent, but it's something I can do and I believe in it." Kenney agreed to discuss her contirbutions for this story. But 314 Action plans to raise \$5 million to \$7 million for current candidates, and it will be impossible to know where the bulk of the money is coming from. That is because the group, named for the first three digits of pi, is taking advantage of a widely used and controversial campaign finance apparatus: a nonprofit arm that does not disclose its donors. This practice has been dubbed the use of "dark money" in the political world. It

has become fairly standard for groups of all stripes—from Republicans to Democrats and from powerful business interests to unions. Planned Parenthood uses these undisclosed donations. So does the National Rifle Association. It is legal. But the practice also means the general public cannot learn much about the original sources of money behind political candidates. Aside from its nonprofit, 314 Action is also raising and spending money via a separate political action committee, or PAC, that is required to report donors to the Federal Election Commission (FEC). But most of the group's funds will come from the nonprofit arm, which has no such requirement. It is registered as a "social welfare" group under section 501(c)(4) of the U.S. tax code. Nonprofits such as this, which advocate for policy issues, are forbidden from contributing directly to candidates. Nor are they allowed to make electioneering their primary activity. But they are allowed to spend some of their money on political TV ads, radio spots, mailers and digital communication to support or oppose candidates without having to disclose donors." (*Scientific American*, 3/28/18)

314 Action Supports U.S. Participation In The Paris Climate Agreement. "Josh Morrow, 314 Action's executive director, says that for the most part the group uses its nonprofit arm to train candidates and for issue-based advocacy such as an online petition in support of the Paris climate agreement. But in this year's elections, for the first time, money from the nonprofit will be used to buy political ads that help candidates who are often scientists running their inaugural campaigns. "For us, it's about leveling the playing field for our nontraditional candidates," Morrow says. He also notes most donors contribute relatively small amounts, not millions of dollars."
